**ORDER LIFTING SUSPENSION AND REINSTATING
CERTIFIED NURSING ASSISTANT CERTIFICATE**

On or about June 20, 2019, the Maryland Board of Nursing (the “Board”) issued a “Final Order of Suspension of Certified Nursing Assistant Certificate for Delinquent Child Support” (“Order of Suspension”), suspending the certified nursing assistant “CNA” certificate a of **RANDY DAVIS SKIPPER**, certificate numbers **A00133600** (the “Respondent”). Pursuant to Md. Code Ann., Family Law (“Fam. Law”) § 10.119.3(e)(2)(i) (2012 Repl. Vol.), upon request of the Prince George’s County Office of Child Support Enforcement Administration of the Maryland Department of Human Resources (the “Administration”), the Board suspended the Respondents’ certificates to practice as a Certified Nursing Assistant in the State of Maryland due to the Respondent’s delinquent child support payments for Child Support Enforcement Administration Case Number **770139236**.

On September 23, 2022, the Board received a “Notice of Compliance” from the Administration for Case Number 770139236. Pursuant to the Maryland Nurse Practice Act, Md. Code Ann., Health Occ. (“Health Occ.”) §§ 8-101 *et seq.*, specifically Health Occ. §§ 8-319(a), the Respondent otherwise qualifies for CNA certificate.

Therefore, pursuant to section 10-119.3(k) of the Family Law Article, on this 28th day of September, 2022, by the Maryland Board of Nursing, it is

Order Lifting Suspension and Reinstating Certified Nursing Assistant Certificate

ORDERED that the suspension of the Respondent's certificate to practice as a certified nursing assistant, certificate number **A00133600**, in the State of Maryland is hereby **LIFTED**; and it is further

ORDERED that the certificate of the Respondent to practice as a certified nursing assistant in the State of Maryland, certificate number **A00133600**, is **REINSTATED** without restrictions or conditions; and it is further

ORDERED that this is a Final Decision and Order of the Maryland Board of Nursing and, as such, is a **PUBLIC RECORD** pursuant to Md. Code Ann., Gen. Prov. § 4-101 *et seq.* (2014).
