**ORDER LIFTING SUSPENSION AND REINSTATING
LICENSED PRACTICAL NURSE LICENSE AND MEDICATION TECHNICIAN
CERTIFICATE**

On or about November 2, 2016, the Maryland Board of Nursing (the “Board”) issued a “Final Order of Suspension of Licensed Practical Nurse License and Medication Technician Certificate for Delinquent Child Support” (“Order of Suspension”), suspending the licensed practical nurse license “LPN” and medication technician certificate “MT” of **KASSIM ABDULLAH YASSIN**, license number **LP39524** and certificate number **MT0023844** (the “Respondent”). Pursuant to Md. Code Ann., Family Law (“Fam. Law”) § 10.119.3 (e)(2)(i) (2012 Repl. Vol.), upon request of the Montgomery County Office of Child Support Enforcement Administration of the Maryland Department of Human Resources (the “Administration”), the Board suspended the Respondent’s license to practice as a Licensed Practical Nurse and certificate to practice as a Medication Technician in the State of Maryland due to the Respondent’s delinquent support payments for Child Support Enforcement Administration Case Number **620082251**.

On June 7, 2022, the Board received a “Notice of Compliance” from the Administration for Case Number 620082251. Pursuant to the Maryland Nurse Practice Act, Md. Code Ann., Health Occ. (“Health Occ.”) §§ 8-319(a), the Respondent otherwise qualifies for an LPN license and MT certificate.

Therefore, pursuant to section 10-119.3(k) of the Family Law Article, on this 8th day of June, 2022, by the Maryland Board of Nursing, it is

ORDERED that the suspension of the Respondent's license to practice as a licensed practical nurse, license number **LP39524**, in the State of Maryland is hereby **LIFTED**; and it is further

ORDERED that the suspension of the Respondent's certificate to practice as a medication technician, certificate number **MT0023844**, in the State of Maryland is hereby **LIFTED**; and it is further

ORDERED that the license of the Respondent to practice as a licensed practical nurse, license number **LP39524**, is **REINSTATED** without restrictions; and it is further

ORDERED that the certificate of the Respondent to practice as a medication technician, certificate number **MT0023844**, is **REINSTATED** without restrictions; and it is further

ORDERED that this is a Final Decision and Order of the Maryland Board of Nursing and, as such, is a **PUBLIC RECORD** pursuant to Md. Code Ann., Gen. Prov. § 4-101 *et seq.* (2014).
