Permanent Voluntary Surrender of Registered Nurse License**

Dear Mr. Hicks,

I agree to permanently voluntarily surrender my license to practice as a registered nurse ("RN") in the State of Maryland, License Number **R245540**. By voluntarily surrendering my Maryland RN license, I understand that I may not engage in the practice as an RN, with or without compensation, as defined in the Maryland Nurse Practice Act ("the Act"), Md. Code Ann., Health Occ. §§ 8-101 *et seq.* (2021 Repl. Vol.) and the Board's regulations, Code of Maryland Regulations ("COMAR") 10.27.01 *et seq.* In other words, I understand that, as of the effective date of this Permanent Voluntary Surrender, I am in the same position as an unlicensed individual.

I understand that this Permanent Voluntary Surrender shall become a **PUBLIC RECORD** and shall become effective on the date of the Board's acceptance of the Permanent Voluntary Surrender. I understand and agree that this Permanent Voluntary Surrender may be released or published by the Board as a final decision and order, on the Board's website and as otherwise permitted, under the Public Information Act, Md. Code Ann., Gen. Prov. §§ 4-101 *et. seq.* (2019). I expressly consent to the publication of this Permanent Voluntary Surrender, including any and all information that is protected from disclosure under federal and state law.

On or about April 30, 2018, I submitted an online Application for RN licensure by Exam ("RN Application") to the Board and indicated that I graduated from Med-Life Institute West Palm Beach, Florida ("Med-Life") on December 1, 2017 and received an associate's degree. I affirmed and agreed to the following statement, "I affirm that the contents of this document are accurate to the best of my knowledge" and that "providing false or misleading information may result in disciplinary action by the Board."

When I registered to take the NCLEX-RN exam, I indicated that I attended Palm Beach School of Nursing and that I graduated in December 2017.

In my written response to the Maryland Board of Nursing's (the "Board") request for information, I stated that I attended Palm Beach School of Nursing from October 2015 until December 2017.

In an affidavit signed on June 7, 2022, Johanah Napoleon, the owner and operator of Palm Beach School of Nursing and Med-Life Institute-WPB, identified me by name and social security number (SSN) as one of the individuals who did not complete the required program hours and clinical training necessary to obtain a transcript or a nursing associate in science degree and transcript from either school.

My Official Transcript from Palm Beach School of Nursing indicates that I completed 18 hours of clinical experience at Palm Beach School of Nursing. In my signed written response to the Board Questionnaire in which I attested that the information provided therein was "true and correct to the best of my knowledge" I stated that I resided in Maryland while attending Palm Beach School of Nursing. I further stated that I completed clinicals in the classroom using ourselves for practice and using mannikins. In my February 16, 2022 written statement to the Board I admitted we did not go to clinicals. In my interview with Board investigators, I admitted I did not have any hands-on direct patient care in a clinical setting at Med-Life.

On March 6, 2023, the Board issued an Order for Summary Suspension of Registered Nurse License ("Order for Summary Suspension"), pursuant to Section 10-226 (c)(2) of the Administrative Procedure Act, which ordered the immediate suspension of my RN license. After a show cause hearing was held, the Board issued an Order Continuing Summary Suspension of Registered Nursing License on April 26, 2023.

On March 30, 2023, the Board issued a Notice of Agency Action - Charges Under the Maryland Nurse Practice Act ("Charges"), charging my RN license with violations under Health Occ. § 8-316 (a).

On or about April 21, 2023, I filed a timely request for hearing on the summary suspension and pending charges.

In lieu of proceeding to an evidentiary hearing on the Charges and Summary Suspension, I agree to the **PERMANENT VOLUNTARY SURRENDER** of my RN license. I understand that if an evidentiary hearing were to be held, the Board would have sufficient evidence to prove by a preponderance of evidence the Investigative Findings in the Order for Summary Suspension and the Allegations of Fact in the Charges and the following violations under Health Occ. § 8-316 (a) (30) "Violates regulations adopted by the Board or an order from the Board" with underlying violations of COMAR 10.27.01.05.A "An applicant for the registered nurse licensure examination shall": (1) "Complete satisfactorily and meet all requirements for a diploma or degree from a registered nursing education program approved by the Board" and (2) "Have a diploma or degree from a registered nursing education program in another state, territory, or country

to be determined to be substantially equivalent¹ to the registered nursing education program approved in this State at the time of the applicant’s graduation.”²

I further understand that the Board would have sufficient evidence to conclude as a matter of law that I violated the Act and to sanction my RN license accordingly pursuant to Md. Code Ann., Health Occ. § 8-316 and COMAR 10.27.26.

I understand in executing this Permanent Voluntary Surrender, I am waiving the right, now and in the future, to any evidentiary hearing at which I would have the right to counsel, to confront witnesses, to give testimony, to call witnesses on my own behalf, and to contest the facts summarized in this Permanent Voluntary Surrender, and at which I would have the right to all other substantive and procedural protections provided by law, including the right to appeal.

In executing this agreement to permanently surrender my RN license, I agree that I will never be eligible for reinstatement of my RN license, license number **R245540**, in the State of Maryland. I agree and understand that if I ever decide to re-apply for licensure as an RN in Maryland, I will approach the Board in the same posture as an unlicensed individual applying for initial RN licensure. I understand that it will be my burden, as an applicant for licensure, to demonstrate that I meet all the Board’s requirements for issuance of an initial license that exist at the time I apply and that I am fit for RN licensure in Maryland.

I agree and understand that, in considering whether to grant any future application for licensure, the Board may review my entire Board file, including any information that the Board receives after execution of this document, and may require me to undergo medical, psychological, and/or psychiatric evaluations and drug and alcohol testing to determine my fitness to receive a license. I understand that the Board is not required to grant me a new RN license.

¹ COMAR 10.27.01.01 C. provides: “Substantially equivalent” means a registered nursing or licensed practical nursing education program that:

- (1) Contains theoretical learning experiences and related clinical learning experiences that include *direct patient care* within various settings consistent with program objectives, outcomes, or competencies conducted either concurrently with or after the theoretical learning experience; and
- (2) Meets the curriculum requirement for Maryland schools of nursing at the time of the applicant’s graduation, including, but not limited to:
 - (c) Didactic and clinical instruction in nursing care of families and clients throughout the life span in a variety of care settings requiring nursing measures appropriate for: ...
 - (d) Didactic and clinical instructional content that includes, but is not limited to, the areas of:
 - (i) Medical and surgical nursing;
 - (ii) Maternal and child health;
 - (iii) Psychiatric nursing; and
 - (iv) Geriatric nursing;

² In its discretion, the Board dismissed the other charges against my RN cited in the March 30, 2023 Charges.

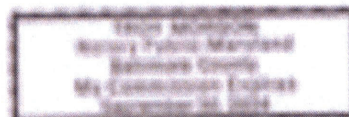
